### SAFE DIVING PRACTICES & AUTHORISATION

(Parent or Guardian if applicant is a Minor)

These safe diving procedures will maximise your diving safety.

1. Divers with 15 logged dives or less must successfully complete a safety orientation dive. Divers who have not dived in the last 12 months must successfully complete a refresher and safety orientation dive.
2. Each diver must check and assemble their own equipment to ascertain that it is in good operating condition.
3. Adhere to the Buddy System throughout every dive. Plan dives with your buddy allowing for your limitations, the prevailing weather conditions, communications, procedures for reuniting in case of separation and emergency procedures.
4. Plan and conduct each dive to be shallower than the previous dive.
5. Plan each dive to be no decompression dives with a margin of safety within the limits of a recognised dive table or computer.
6. Limit your dive depth to your level of training & experience. A maximum dive depth of 30m (100ft).
7. Drink plenty of water before and after each dive to avoid dehydration and reduce the risk of decompression illness.
8. Refrain from drinking alcohol until after your last dive of the day. Do not take any illegal drugs.
9. Be a SAFE diver - Slowly ascend from every dive. Ascend at a rate not more than 10m (30ft) per minute.
10. Maintain proper buoyancy throughout the entire dive, pay attention to the control of your BCD during ascent.
11. Complete a safety stop at the end of every dive at 5m (15ft) for 3 minutes.
12. If you are feeling unwell after a dive, or at any time during your stay, please advise a member of our team for assistance.
13. I understand that diving is a potentially dangerous activity. I fully accept that risk and agree to pay any medical, vessel relocation or air evacuation costs incurred on my behalf and you are authorised to make medical and transport arrangements as may be determined to be necessary or desirable in my best interests.

I confirm that my dive history is correct and I agree to comply with the Safe Diving Practices detailed above, and the directions / dive briefings given to me by the LEIER Dive Team.

### CONDITIONS & RELEASE OF LIABILITY

#### 1. EQUIPMENT AGREEMENT

I agree to reimburse Lady Elliot Island Eco Resort for any of their diving equipment lost or damaged whilst in my care.

#### 2. MEDICAL STATEMENT:

I understand that scuba diving is a physically strenuous activity and that I will be exerting myself during the diving activity. I state that I am in good health for diving, I have no medical history of heart or lung disorders, abnormal blood pressure, asthma or epilepsy, nor am I an insulin dependent diabetic. I will not dive if I am feeling unwell or I have a chest cold or respiratory congestion during my stay. I understand if I have any medical condition contrary to these requirements I must produce a diving medical certificate completed by a diving medical specialist. You are authorised to make medical and transport arrangements as may be determined in my best interest. I agree to pay all expenses incurred on my behalf, for evacuation / medical treatment, which may be charged against my credit card.

#### 3. DISCHARGE OF LIABILITY

It is a fundamental condition of this contract between Lady Elliot Island Eco Resort (referred to as LEIER) and its owners, partners, sub-contractors, agents and employees on the one part and I the undersigned on the other part, that to the extent permitted by law LEIER is hereby discharged by me/our executors(s), my/our administrator(s) and my/our dependant(s) from any liability for any personal injury, property damage, or wrongful death occurring to me whatsoever arising out of or incidental to the diving services or boat travel provided by LEIER whether or not such damage or personal injury is caused or contributed to by LEIER. I further acknowledge I am aware of the risks of injury associated with my participation in this activity and agree that I voluntarily assume such risk of injury.
